## **Entry Requirements**



Please make sure that you fulfill the entry requirements for each port of your cruise.

Your Passport has to be valid at least **6 months** after the end of your voyage for all countries, regardless of destination. Please also make sure that you have enough free pages in your passport available.

## Please make sure you have all up-to-date information about vaccinations as well. E.g. a Yellow Fever vaccination is required at some ports in Africa and South America.
