

Please read the following information carefully to guarantee a relaxed start into your vacation.

PASSENGER IMMIGRATION FORM

Due to the strict security regulations of the US-entry authority, we are bounded by the local authorities to hand out your personal data of the passenger immigration form.

Every passenger is obligated to fill in this form completely and to provide it to Princess Cruises / Inter Connect Marketing at least 6 weeks before Embarkation Day. Without the Passenger Immigration Form we can not issue your travel documents.

You can complete the Passenger Immigration Form online at <u>www.princesscruises.com</u> (Link: Cruise Personalizer) or send it to us by fax 089-51703-102 or mail. **Please note, that without correct and full names, boarding may be denied!**

The declaration of your credit card information is optional.

Most Ports offer an Express Check-in and a faster handling. To provide this convenience the details of your credit card are necessary. The credit card should be issued within 6 weeks before departure and has to be valid at least 1 month after disembarkation day.

If boarding will be denied due to missing or wrong passenger immigration, the full cancelation fee will be charged (please read our terms and conditions).

PASSPORT AND VISA

All passengers need a machine-readably passport which has to be valid 6 months after the return date and must have enough empty pages for entry- and departure marks.

All passengers under 21 years must be accompanied by a passenger who is 21 years or older. For family groups booking multiple staterooms, children may sail in a cabin without their parents or guardians, provided one child in the stateroom is a minimum of 16 years of age or older.

Please note that a notarized written consent for passengers under the age of 18 years is no longer required by Princess. However, several countries require special documentation for children travelling without both parents; these requirements are subject to change without notice. In case of the sole right of custody, a running divorce, an adoption or similar circumstances, a certificate is necessary. With non-presentation Boarding may be denied.

It is your responsibility to ensure that you possess the proper documents for all of the countries that you will visit. Please verify requirements with the immigration offices prior to your cruise.

You will find the Visa Requirements for German Citizens attached to the invoice. *** subject to short-term changes***

Citizen of other countries should contact the embassy of each port, to get information about Visa Duties.



VACCINATIONS

Regulations with regard to vaccination certificates and other health requirements for the various embarkation ports may vary by destination and change from time to time. It is the sole responsibility of the passenger to obtain and have available when necessary the appropriate valid travel and health documents such as vaccination certificates, that are necessary for air travel, disembarkation at the various ports of call and reentry into the appropriate country of origin. Passengers who do not possess the proper documentation will be prevented from boarding the flight or vessel without refund of the cruise or cruisetour fare and will be subject to any fine or other costs incurred by Princess which result from the lack of proper documentation.

For some Cruises with Princess Cruises a Yellow Fever Vaccination is required. This Vaccination is also necessary if you have visited a risk area immediately before.

Please inform yourself especially for the areas South America, the Amazon, Panama, Africa and the Caribbean for the required vaccination regulations.

For further Information please contact your doctor, the Institute of the Tropes or the Department for Foreign Affairs. In case of a new introduced vaccination regulation we will be sure to inform you.

GENERAL INFORMATION

Currency on board:	US-Dollar (Australia-Dollar on cruises with P&O Australia from/to Australia with Dawn and Sun Princess)
Payment on Board:	Another convenience of cruising with Princess is being able to sign for all of your shipboard expenses, excluding Stamps. You'll receive an itemized statement of all charges the night before disembarkation, and having registered your credit card at embarkation, your onboard account will automatically be settled on the day of disembark with no need to wait in line. To confirm the payment of your Port Folio by Credit Card, you have to sign a form at Check-In. Unless otherwise noted Princess Cruises will charge your credit card automatically in your Currency. If you prefer to pay in USD please mark it on your Boarding Pass at Check–In. All Credit Cards are permitted. Euro Currency, US Currency, Canadian Currency, British Currency and Traveller Checks are also accepted. Those paying by traveler's checks or cash required to leave a \$ 300,00 USD per person cash deposit with the Pursers/Passenger Services Desk at the beginning of the cruise.
Food and Beverages:	On all Princess Ships you have full board. This includes all meals In the main Dining Rooms, as well as Tea, Coffee, Water and Iced Tea. Princess offers you the possibility to purchase a non-alcoholic soda fountain package (approx. 4,50 USD per day per Person)

Seatings:	On your passenger Immigration Form you are able to choose the seating for your Dining. You can choose between traditional early Seating (approx. 6:00 pm), traditional late Seating (approx. 8:00 pm) or Anytime Dining (between 5:30 pm and 10:00 pm). In addition you have always the possibility to choose our Buffetrestaurant. Enjoy early or late Seating in the same dining room with the same waiter and tables each evening or decide for Anytime Dining with whomever you wish to dine and according to your own schedule. For a reservation charge you may also choose our speciality Restaurants, such as our fine Italian Restaurant or our delicious Steakhouse.

Smoking:	Smoking is not allowed in passenger staterooms, balconies but only in designated areas on deck and public rooms. However, show lounges, dining rooms and all food service areas onboard all Princess Ships are non-smoking. Passengers must be 18 years of Age or older.
Shore Excursions:	Princess Cruises offers you a wide range of English speaking Shore Excursions. They can be booked approx. 100 days prior to your Sailing via our Homepage <u>www.princesscruises.de</u> \rightarrow Cruise Personalizer, where you also find detailed description. In addition you have the possibility to book the Shore Excursions via Fax or directly on Board. The Cancellation of Shore Excursions is free of charge until 48 hours prior to their start.
Captain Circle:	To become a Member of our Captain Circle Programm simply complete your first Princess voyage. As a Captain Circle Member you can take advantage of different Offers on Board.
Medical Facilities:	Our onboard medical centers are staffed by full-time British registered doctors and nurses. They are available 24 hours a day in the event of an emergency. Princess cannot accept passengers who will have entered the 24 th week of pregnancy by the end of the vacation. If you regularly take any medications, you are strongly advised to carry them in your hand luggage and to bring extra supplies to cover any unexpected circumstances.
Calling the ship:	You will be always reachable during your cruise. The phone number of your ship is provided in your cruise documents.
Travel Documents:	Your Travel Documents will be sent to your travel agency 4 weeks prior to sailing. Please let us know if you need the documents earlier.
